Monday, September 9, 2013

The Gulf County School Board met in regular session Monday September 9, 2013, at 4:30 P. M. (Workshop), 5:15 P. M. (Public Hearing and Vote on Final Budget), followed by the regular scheduled board meeting at their Administrative Office in Port St. Joe. The following board members were present: Chairman Linda R. Wood, Vice-Chairman George M. Cox, Danny Little, Billy C. Quinn, Jr., and John Wright. Superintendent Norton and Attorney Costin were also present.

## **4:30 Workshop Agenda -**

- 1) Representatives from the Gulf County Health Department (Jessie Pippin and Sara Hines) provided information to the Board outlining their desire to see the district develop a more comprehensive Tobacco Policy. They also asked the Board to review information (to be provided) for the proposed abstinence curriculum to be taught to 6<sup>th</sup> grade students in October. (SM:13-117)
- 2) Tamara Marler (Tyndall Air Force Base School Liaison Officer) addressed the Board regarding the District's hope to garner the attention of current and future military families and civilian workers.
