The Gulf County School Board met in regular session Tuesday, September 9, 2014, at 4:45 P. M. (Workshop) and 5:15 P. M. (Public Hearing on the Final Budget and School Board Meeting) at their Administrative Office in Port St. Joe. The following board members were present: Chairman Linda R. Wood, Vice-Chairman George M. Cox, Danny Little, Billy C. Quinn, Jr., and John Wright. Superintendent Norton and Attorney Costin were also present.

4:45 Workshop: Chairman Wood called the workshop to order at 4:45 P. M., E.T.
